As you may be aware, we represent Defendant American Behavioral Research Institute LLC (“ABRI”) in the above-captioned matter.

ABRI was served with a copy of the Complaint on or about July 25, 2022 and an answer was due by August 15, 2022. *See*, Dkt. No. 8. After obtaining a first extension of time to respond, on October 12, 2022, ABRI sought an extension until November 14, 2022 of its time to respond to the Complaint, which was stipulated to by Plaintiff’s counsel, and which the Court granted. *See*, Dkt. Nos. 10, 13-15.
