The parties jointly submit this Subsequent Case Management Statement in advance of the upcoming March 31, 2021 Case Management Videoconference. The parties have previously submitted a full Joint Case Management Statement, *see* Dkt. 28, as well as three supplemental Joint Case Management Statements, *see* Dkts. 68, 81, and 88. The parties now submit this supplemental Case Management Statement. Pursuant to Local Rule 16-10(d), the parties will focus this statement only on “progress or changes since the last statement was filed” and “proposals for the remainder of the case development process.”

On August 6, 2019, this Court denied Defendant Coinbase’s Motion to Compel Arbitration (Dkt. No. 75); Coinbase subsequently docketed an appeal from the Court’s order on August 13, 2019. Following oral argument on December 9, 2020, the Ninth Circuit Court of Appeals issued a ruling on December 23, 2020, reversing this Court’s order denying Coinbase’s motion to compel arbitration and remanding with instructions to compel arbitration. (Dkt. No. 96.) The Ninth Circuit’s judgment was entered on January 14, 2021. (Dkt. No. 97.) The parties will be available to discuss next steps at the March 31, 2021 conference.
