## FUBO DATA PRIVACY SETTLEMENT CLAIM FORM

## I. <u>INSTRUCTIONS</u>

You can submit this Claim Form online at www.VPPADataPrivacyFuboSettlement.com or by mail to the address listed above. The deadline to submit or postmark a claim is September 12, 2025.

To receive a Cash Payment from this Settlement via an electronic payment, you must submit the Claim Form below electronically at www.VPPADataPrivacyFuboSettlement.com by September 12, 2025.

If you have any questions about any of the terms in this Claim Form, please review the detailed Published Notice or the Settlement Agreement, both available for review at www.VPPADataPrivacyFuboSettlement.com. If you, while residing in the United States or its territories: (i) had an account to use the Fubo Platform on or before May 29, 2025, or (ii) used the Fubo account of another Person on or before May 29, 2025, you may qualify as a "Settlement Class Member" and submit or postmark this Claim Form by September 12, 2025, to request a Cash Payment. Each Settlement Class Member may only submit a single Claim Form.

If the Settlement is approved and your claim is deemed valid, a check will be mailed to you or electronic payment will be sent to the account you choose. The amount of the payment is currently unknown, but all Settlement Class Members who submit Approved Claims will receive an identical share of the \$3.4 million Cash Fund after payment of Settlement Fees and Expenses, Attorneys' Fees and Expenses, and Service Awards. Additionally, Settlement Class Members who make the California-specific certifications (set forth in Section IV(2)(b) of the Settlement Agreement) will be entitled to a Cash Payment of 1.1 times the Cash Payment amount distributed to Settlement Class Members who do not make those California-specific certifications. Submitting a valid and timely Claim Form is the only way to receive a Cash Payment from this Settlement.
