CLASS ACTION COMPLAINT

1 **I. INTRODUCTION**

2 Whenever someone watches a video on www.hallmarkvideogreetingcards.com
3 (the “Website”), Defendants secretly report all the details to Facebook: the visitor’s
4 identity, the titles watched, and more. Why? So Facebook can bombard the person with
5 *more* ads urging the person to buy products from Defendants.

6 As shown below, Defendants’ actions violate the Video Privacy Protection Act
7 (“VPPA”). As such, Defendants are liable to each class member for \$2,500 and related
8 relief.

9 **II. JURISDICTION AND VENUE**

10 1. This Court has subject matter jurisdiction over this action pursuant to 28
11 U.S.C. § 1331 because it arises under the Video Privacy Protection Act (“VPPA”), a
12 federal law.

13 2. Venue is proper pursuant to 28 U.S.C. § 1391 because a substantial part of
14 the acts and events giving rise to the claims occurred in this District.

15 3. Defendants are subject to personal jurisdiction because they have sufficient
16 minimum contacts with California and do business with California residents.

17 **III. PARTIES**

18 4. Plaintiff Jesse Cantu (“Plaintiff”) is a resident and citizen of California.

19 5. Defendant Hallmark is a Missouri entity owns, operates, and/or controls the
20 Website.

21 6. The above-named Defendants, along with their affiliates and agents, are
22 collectively referred to as “Defendants.” The true names and capacities of the Defendants
23 sued herein as DOE DEFENDANTS 1 through 25, inclusive, are currently unknown to
24 Plaintiff, who therefore sues such Defendants by fictitious names. Each of the Defendants
25 designated herein as a DOE is legally responsible for the unlawful acts alleged herein.
26 Plaintiff will seek leave of Court to amend the Complaint to reflect the true names and
27 capacities of the DOE Defendants when such identities become known.

1 7. Plaintiff is informed and believes that at all relevant times, every Defendant
2 was acting as an agent and/or employee of each of the other Defendants and was acting
3 within the course and scope of said agency and/or employment with the full knowledge
4 and consent of each of the other Defendants, and that each of the acts and/or omissions
5 complained of herein was ratified by each of the other Defendants.

6 **IV. FACTUAL ALLEGATIONS**

7 **A. THE FACEBOOK TRACKING PIXEL**

8 8. Facebook is a social networking company where users are required to
9 identify themselves by “the name they go by in everyday life.”¹ To create a Facebook
10 account, a user must provide first name, last name, date of birth and gender.²

11 9. Facebook generates revenue by selling advertising space on its website
12 based upon its ability to identify user interests.³ Facebook can identify user interests by
13 monitoring “offsite” user activity, which allows Facebook to judge user interests beyond
14 what users freely disclose.⁴

15 10. Facebook enables advertisers to identify “people who have already shown
16 interest in [their] business”, which Facebook calls “Custom Audiences.”⁵ The Custom
17 Audiences tool requires advertisers to supply user data to Facebook, and most do so via
18 the Facebook Tracking Pixel.⁶

1 11. The Facebook Tracking Pixel is a device included programming code that
 2 advertisers can integrate into their website. Once activated, the Facebook Tracking Pixel
 3 “tracks the people and type of actions they take.”⁷ When the Facebook Tracking Pixel
 4 captures an action, it sends a record to Facebook, which Facebook then assimilates into
 5 the Custom Audiences dataset.

6 12. Advertisers control what actions—or, as Facebook calls it, “events”— the
 7 Facebook Tracking Pixel will collect, including the website’s metadata, along with what
 8 pages a visitor views.⁸

9 13. Advertisers control how the Facebook Tracking Pixel identifies visitors. The
 10 Facebook Tracking Pixel is configured to automatically collect “HTTP Headers” and
 11 “Pixel-specific Data.”⁹ HTTP Headers collect “IP addresses, information about the web
 12 browser, page location, document, referrer and persons using the website.”¹⁰ Pixel-
 13 specific Data includes “the Pixel ID and cookie.”¹¹

14 **B. HALLMARKVIDEOGREETINGCARDS.COM AND THE FACEBOOK**
 15 **PIXEL**

16 14. Defendants’ business plan involves persuading potential customers to watch
 17 video greeting cards. As such, Defendants are “video tape service providers” under the
 18 VPPA because, as part of their business, they deliver “prerecorded video” content or
 19 other “similar audio visual materials.”

20 15. Hallmarkvideogreetingcards.com hosts and delivers content including
 21 videos.

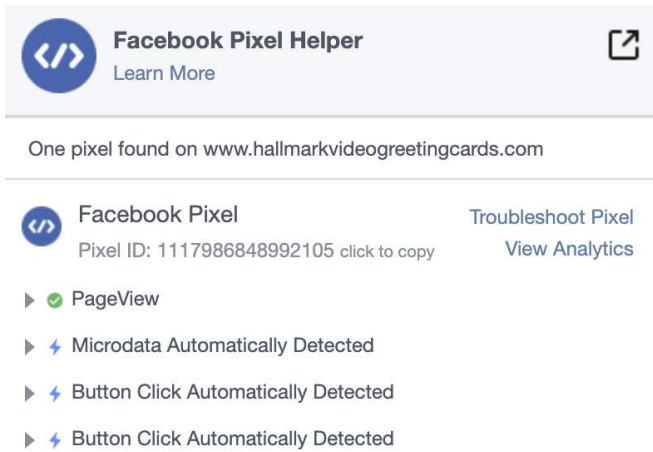

1 16. Hallmarkvideogreetingcards.com hosts the Facebook tracking Pixel and
2 transmits numerous distinct events to Facebook.¹²

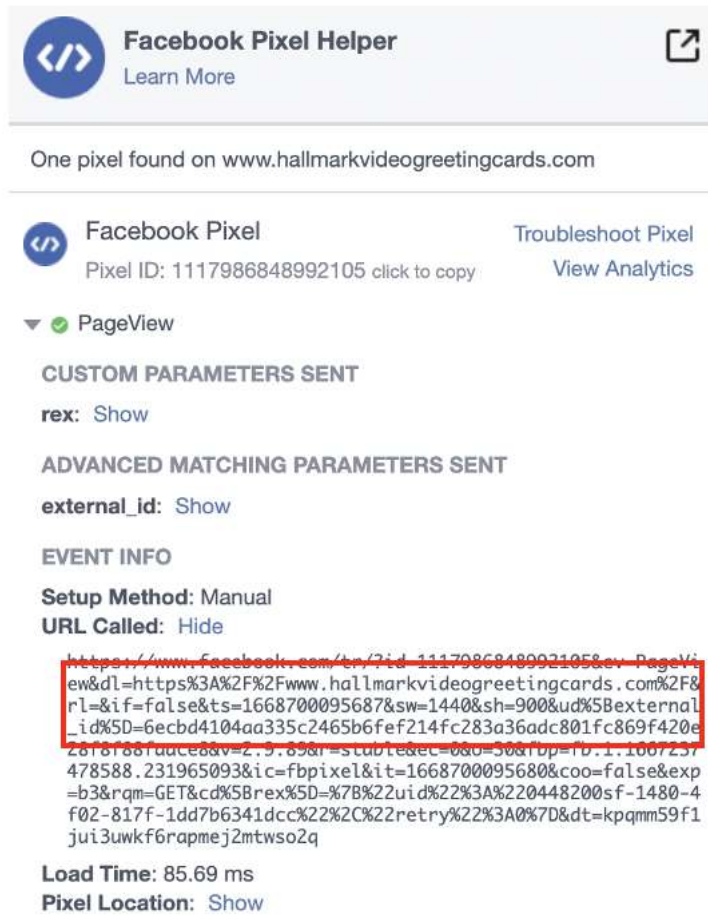

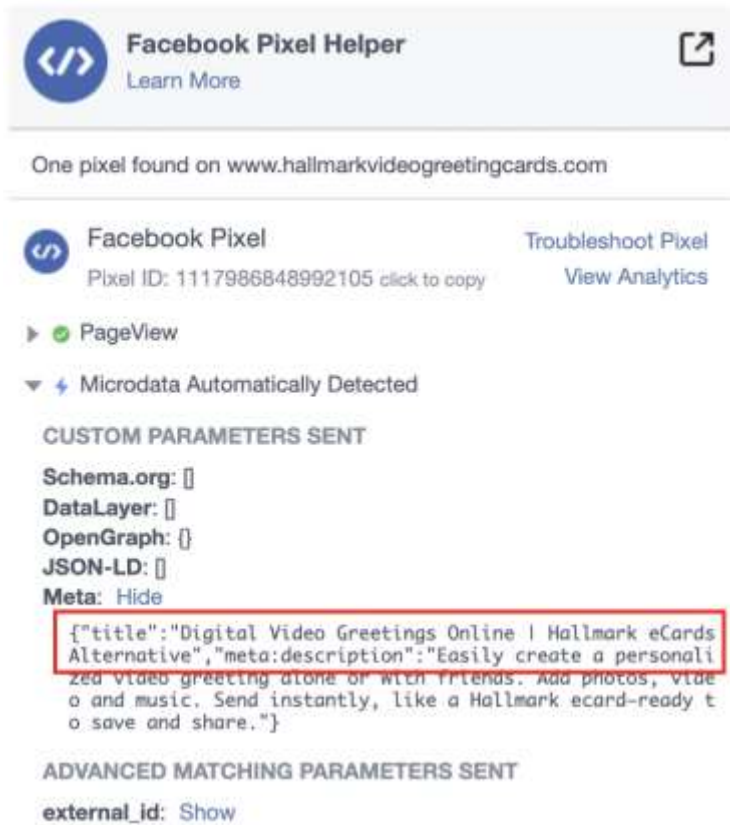

18 18. In the above figure, for example, Defendants disclose a webpage’s
19 Universal Resource Locator (“URL”).

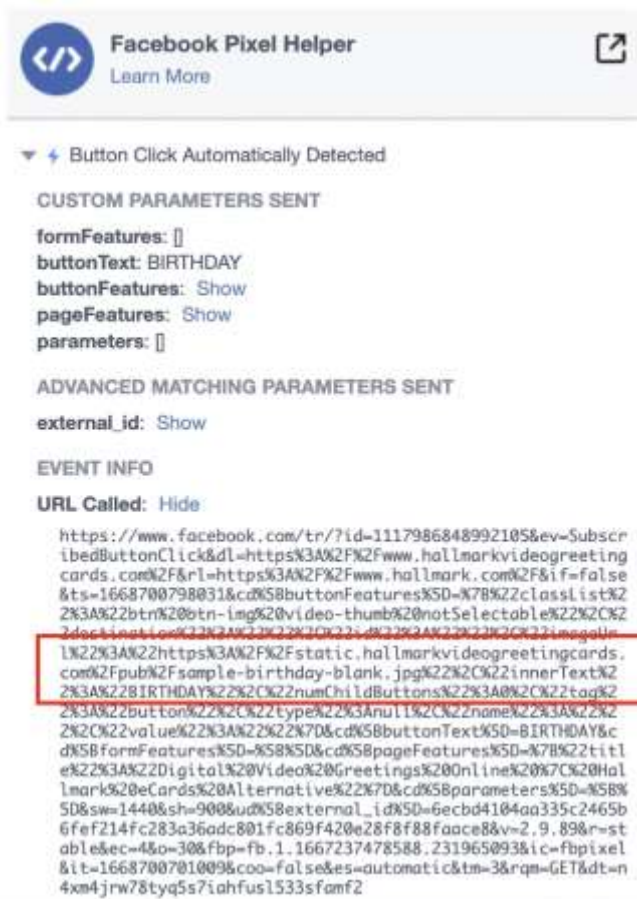
20 19. Microdata discloses the video’s title and other descriptors.

18 20. The “Button Click Automatically Detected” event discloses when the
19 video’s play button is clicked by the visitor along with descriptive information about the
20 button, page, and video.

21. The aggregate pixel events (Page View, Microdata Automatically Detected, and Button Click Automatically Detected) permit an ordinary person to identify a video’s content, title, and location.

22. When a visitor watches a video on Hallmarkvideogreetingcards.com while logged into Facebook, Defendants compel a visitor’s browser to transmit the c user cookie to Facebook. The c user cookie contains that visitor’s unencrypted Facebook ID. When accessing the above video, for example, Defendants compelled the browser to send eight cookies:

23. When a visitor's browser has recently logged out of Facebook, Defendants will compel the browser to send a smaller set of cookies:

24. The fr cookie contains an encrypted Facebook ID and browser identifier.¹³ The datr cookies also identifies a browser.¹⁴ Facebook, at a minimum, uses the fr cookie to identify particular users.¹⁵

25. The _fbp cookie contains, at least, an unencrypted value that uniquely identifies a browser.¹⁶ As with the fr cookie, Facebook uses the _fbp cookie to identify users.

26. The Facebook Tracking Pixel uses both first- and third-party cookies. A first-party cookie is “created by the website the user is visiting”—i.e., Hallmarkvideogreetingcards.com.¹⁷ A third-party cookie is “created by a website with a domain name other than the one the user is currently visiting”—i.e., Facebook.¹⁸ The _fbp cookie is always transmitted as a first-party cookie. A duplicate _fbp cookie is sometimes sent as a third-party cookie, depending on whether the browser has recently logged into Facebook.

27. Facebook, at a minimum, uses the fr, _fbp, and c_user cookies to link to Facebook IDs and corresponding Facebook profiles.

28. A Facebook ID is personally identifiable information. Anyone can identify a Facebook profile—and all personal information publicly listed on that profile—by appending the Facebook ID to the end of Facebook.com.

29. Through the Facebook Tracking Pixel’s code, these cookies combine the identifiers with the event data, allowing Facebook to know, among other things, what Hallmarkvideogreetingcards.com videos a user has watched.¹⁹

1 30. By compelling a visitor’s browser to disclose the c_user cookie alongside
2 event data for videos, Defendants knowingly disclose information sufficiently permitting
3 an ordinary person to identify a specific individual’s video viewing behavior.

4 31. By compelling a visitor’s browser to disclose the fr and _fbp cookies
5 alongside event data for videos, Defendants knowingly disclose information sufficient to
6 permit an ordinary person to identify a specific individual’s video viewing behavior.

7 32. By compelling a visitor’s browser to disclose the fr cookie and other browser
8 identifiers alongside event data for videos, Defendants knowingly disclose information
9 sufficiently permitting an ordinary person to identify a specific individual’s video
10 viewing behavior.

11 33. Facebook confirms that it matches activity on
12 Hallmarkvideogreetingcards.com with a user’s profile. Facebook allows users to
13 download their “off-site activity,” which is a “summary of activity that businesses and
14 organizations share with us about your interactions, such as visiting their apps or
15 websites.”²⁰ The off-site activity report confirms Defendants identify an individual’s
16 video viewing activities.

17 **C. EXPERIENCE OF PLAINTIFF**

18 34. Plaintiff is a consumer privacy advocate with dual motivations for watching
19 a video on Defendants’ Website. First, Plaintiff was genuinely interested in learning
20 more about the goods and services offered by Defendants. Second, Plaintiff is a “tester”
21 who works to ensure that companies abide by the privacy obligations imposed by federal
22 law. As someone who advances important public interests at the risk of vile personal
23 attacks, Plaintiff should be “praised rather than vilified.” *Murray v. GMAC Mortgage*
24 *Corp.*, 434 F.3d 948, 954 (7th Cir. 2006).

1 35. In enacting the VPAA, Congress intentionally chose to extend its
2 protections to all persons who watch videos, not simply those who purchase them or
3 claim pecuniary loss. As such, statutes like the VPPA are largely enforced by civic-
4 minded “testers” such as Plaintiff. *See Tourgeman v. Collins Fin. Servs., Inc.*, 755 F.3d
5 1109 (9th Cir. 2014) (explaining why testers have Article III standing and generally
6 discussing value and importance of testers in enforcement of consumer protection and
7 civil rights statutes).²¹

8 36. During 2022, Plaintiff visited Hallmarkvideogreetingcards.com and
9 watched a video.

10 37. When Plaintiff watched videos on Hallmarkvideogreetingcards.com,
11 Defendants disclosed event data, which recorded and disclosed the video’s title and URL,
12 along with every time Plaintiff clicked a button to play the video. Alongside this event
13 data, Defendants also disclosed identifiers for Plaintiff, including the c_user and fr
14 cookies. In other words, Defendants did exactly what the VPPA prohibits: they disclosed
15 Plaintiff’s video viewing habits to a third party.

16 38. Given the nature of Defendants’ business, the content of videos that visitors
17 watch is potentially highly sensitive. Visitors would be shocked and appalled to know
18 that Defendants secretly disclose to Facebook all of key data regarding a visitors’ viewing
19 habits.”

20 39. Defendants’ conduct is illegal, offensive, and contrary to visitor
21 expectations: indeed, a recent study conducted by the Electronic Privacy Information
22 Center, a respected thought leader regarding digital privacy, found that: (1) nearly 9 in
23

1 10 adults are “very concerned” about data privacy, and (2) 75% of adults are unaware of
2 the extent to which companies gather, store, and exploit their personal data.

3 40. By disclosing his event data and identifiers, Defendants disclosed Plaintiff’s
4 personally identifiable information (“PII”) to a third-party.

5 41. Plaintiff discovered that Defendants surreptitiously collected and
6 transmitted his personally identifiable information in November 2022.

7 **CLASS ALLEGATIONS**

8 42. Plaintiff brings this action individually and on behalf of all others similarly
9 situated (the “Class”) defined as follows:

10 **All persons in the United States who watched video content on**
11 **Hallmarkvideogreetingcards.com and whose PII was disclosed by**
12 **Defendants to Facebook during the Class Period.**

13 43. **Numerosity (Fed. R. Civ. P. 23(a)(1)):** At this time, Plaintiff does not know
14 the exact number of members of the aforementioned Class. However, given the
15 popularity of Defendant’s website, the number of persons within the Class is believed to
16 be so numerous that joinder of all members is impractical.

17 44. **Commonality and Predominance (Fed.R.Civ.P. 23(a)(2), 23(b)(3)):**
18 There is a well-defined community of interest in the questions of law and fact involved
19 in this case. Questions of law and fact common to the members of the Class that
20 predominate over questions that may affect individual members of the Class include:

- 21 a) whether Defendants collected Plaintiff’s and the Class’s PII;
- 22 b) whether Defendants unlawfully disclosed and continues to disclose their
23 users’ PII in violation of the VPPA;
- 24 c) whether Defendants’ disclosures were committed knowingly; and
- 25 d) whether Defendants disclosed Plaintiff’s and the Class’s PII without
26 consent.
27

1 45. **Typicality (Fed. R. Civ. P. 23(a)(3)):** Plaintiff’s claims are typical of those
2 of the Class because Plaintiff, like all members of the Class, used
3 Hallmarkvideogreetingcards.com to watch videos, and had PII collected and disclosed
4 by Defendants.

5 46. **Adequacy (Fed. R. Civ. P. 23(a)(4)):** Plaintiff has retained and is
6 represented by qualified and competent counsel who are highly experienced in complex
7 consumer class action litigation. Moreover, Plaintiff is able to fairly and adequately
8 represent and protect the interests of the Class.

9 47. **Superiority (Fed. R. Civ. P. 23(b)(3)):** A class action is superior to other
10 available methods for the fair and efficient adjudication of this controversy because
11 individual litigation of the claims of all members of the Class is impracticable. Even if
12 every member of the Class could afford to pursue individual litigation, the court system
13 could not. It would be unduly burdensome to the courts in which individual litigation of
14 numerous cases would proceed. Individualized litigation would also present the potential
15 for varying, inconsistent, or contradictory judgments, and would magnify the delay and
16 expense to all parties and to the court system resulting from multiple trials of the same
17 factual issues. By contrast, the maintenance of this action as a class action, with respect
18 to some or all of the issues presented herein, presents few management difficulties,
19 conserves the resources of the parties and of the court system and protects the rights of
20 each member of the Class. Plaintiff anticipates no difficulty in the management of this
21 action as a class action.

22 **CAUSE OF ACTION**

23 **VIOLATION OF THE VIDEO PRIVACY PROTECTION ACT**

24 **18 U.S.C. § 2710, *et seq.***

25 48. Defendants are a “video tape service provider” because it creates, hosts, and
26 delivers videos on its website, thereby “engag[ing] in the business, in or affecting
27 interstate or foreign commerce, of rental, sale, or delivery of prerecorded video cassette
28

1 tapes or similar audio visual materials.” 18 U.S.C. § 2710(a)(4). Defendants also use the
2 videos to collect and disclose viewers’ PII so it can later retarget them for advertisements.

3 49. Plaintiff and members of the Class are “consumers” because they have
4 watched videos on Hallmarkvideogreetingcards.com. 18 U.S.C. § 2710(a)(1).

5 50. Defendants disclosed to a third party, Facebook, Plaintiff’s and the Class
6 members’ personally identifiable information. Defendants utilized the Facebook
7 Tracking Pixel to compel Plaintiff’s web browser to transfer Plaintiff’s identifying
8 information, like his Facebook ID, along with Plaintiff’s event data, like the title of the
9 videos he viewed.

10 51. Plaintiff and the Class members viewed videos using
11 Hallmarkvideogreetingcards.com.

12 52. Defendants knowingly disclosed Plaintiff’s PII because it used that data to
13 build audiences on Facebook and retarget them for its advertising campaigns.

14 53. Plaintiff and Class members did not provide Defendants with any form of
15 consent—either written or otherwise—to disclose their PII to third parties.

16 54. Defendant’s disclosures were not made in the “ordinary course of business”
17 as the term is defined by the VPPA because they were not necessary for “debt collection
18 activities, order fulfillment, request processing, [or] transfer of ownership.” 18 U.S.C. §
19 2710(a)(2).

20 **PRAYER FOR RELIEF**

21 WHEREFORE, Plaintiff seeks judgment against Defendant, individually and on
22 behalf of all others similarly situated, as follows:

- 23 a. For an order certifying the Class under Rule 23 of the Federal Rules of Civil
24 Procedure, naming Plaintiff as representative of the Class;
- 25 b. For an order declaring that Defendant’s conduct violates the VPPA;
- 26 c. For an order finding in favor of Plaintiff and the Class on all counts asserted
27 herein;
- 28 d. An award of statutory damages under the VPAA;

- 1 e. An award of punitive damages;
- 2 f. For prejudgment interest on all amounts awarded;
- 3 g. For injunctive relief to stop the illegal conduct; and
- 4 h. For an order awarding Plaintiff and the Class their reasonable attorneys'
5 fees, expenses and costs of suit.
