Dear Sample A. Sample:

Commonwealth Business Bank ("CBB") writes to inform you of a recent data security event that may involve certain information related to you. We are providing you with information about the event, our response, and steps you may take to better protect against the possibility of identity theft and fraud, should you determine it appropriate to do so.

What Happened? On or about February 6, 2025, CBB became aware of suspicious activity affecting certain systems within its network. Upon becoming aware, we promptly took steps to secure our environment and launched a comprehensive investigation with the assistance of third-party cybersecurity specialists to determine the full nature and scope of the event. The investigation determined there was unauthorized access to CBB's environment between January 25, 2025, and February 8, 2025, and that certain files and folders within the network were or potentially were viewed and/or acquired without authorization during that time. We recently completed a comprehensive review of the files to determine the sensitive information potentially involved and to whom it relates.

What Information Was Involved? The investigation determined that the following information was accessible and may have been impacted: your name and [Extra4].

What We Are Doing. The confidentiality, privacy and security of information in our care is one of our highest priorities. Upon becoming aware of this event, we immediately took steps to secure our environment and conducted a comprehensive investigation to confirm the nature and scope of the activity and determine what information may be involved. We implemented additional cybersecurity measures and reviewed existing security policies to further protect against similar events moving forward. CBB has also been working with federal regulatory agencies and law enforcement throughout the incident.

What You Can Do. We encourage you to remain vigilant for the next 12 to 24 months for incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors. You should promptly report instances of identity theft or fraud to the relevant financial institution and law enforcement. Please review the *Steps You Can Take to Help Protect Your Personal Information* for useful information on what you can do to better protect against possible misuse of your information. You may also enroll in the free credit monitoring services we have provided for you through Experian. Enrollment details on these services are included in the *Steps You Can Take to Help Protect Your Personal Information* section of this letter. Please note the deadline is November 28, 2025 and we are unable to enroll in these services for you.

Enroll in Monitoring Services

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended "fraud alert" on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a "credit freeze" on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer's express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer's name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

- 1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
- 2. Social Security number;
- 3. Date of birth;
- 4. Addresses for the prior two to five years;
- 5. Proof of current address, such as a current utility bill or telephone bill;
- 6. A legible photocopy of a government-issued identification card (state driver's license or ID card, etc.); and
- 7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Additional Information

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General. The Federal Trade Commission also encourages those who discover that their information has been misused to file a complaint with them. Consumers have the right to file a police report if they ever experience identity theft or fraud. Please note that in order to file a report with law enforcement for identity theft, consumers will likely need to provide some proof that they have been a victim. Instances of known or suspected identity theft should also be reported to law enforcement and the relevant state attorney general. This notice has not been delayed by law enforcement.
