1 Pursuant to Civil Local Rule 7-12, Plaintiff Kent Hassell (“Plaintiff”) and Defendant
2 Uber Technologies, Inc. (“Defendant”) (collectively, “Parties”) by and through their respective
3 counsel of record, hereby stipulate as follows:

4 WHEREAS, on January 4, 2021, Plaintiff filed a Notice of Filing of First Amended
5 Complaint against Defendant;

6 WHEREAS, on January 6, 2021, at the Clerk’s direction, Plaintiff re-filed his First
7 Amended Complaint directly (and not as an exhibit to the notice);

8 WHEREAS, the deadlines for Plaintiff’s Motion for Class Certification and Motion for
9 Summary Judgment are currently set for February 17, 2022;

10 WHEREAS, the Parties have reached a tentative resolution of this matter and have
11 filed a Motion for Preliminary Approval of Class Action Settlement in the related case, James v.
12 Uber Technologies, Inc. Case No. 19-CV-06462-EMC (N.D. Cal.) on February 17, 2022, which
13 would resolve all pending claims in this matter;

14 WHEREAS, in order to conserve costs and judicial resources, and in the interests of
15 efficiency and economy, the Parties request that all hearings be vacated and all deadlines,
16 including but not limited to Plaintiff’s deadlines to file his Motion for Class Certification and
17 Motion for Summary Judgment, be suspended while the parties finalize the settlement;

18 NOW THEREFORE, the Parties hereby stipulate, agree, and respectfully request that
19 the Court enter an Order establishing the following:

20 This action shall be stayed in light of the parties’ proposed settlement.
