**AMENDMENT TO PRIOR ORDER GRANTING PRELIMINARY
APPROVAL OF CLASS ACTION SETTLEMENT AND CONDITIONALLY
CERTIFYING SETTLEMENT CLASS**

The Court will hold a Final Approval Hearing on November 30, 2026, at 2:00 p.m., in the Courtroom of the Honorable Jennifer G. Weems, Circuit Court of Calhoun County, Alabama, Seventh Judicial Circuit, 25 W 11th Street, Anniston, Alabama 36201, to consider: (a) whether certification of the Settlement Class for settlement purposes only should be approved; (b) whether the Settlement should be approved as fair, reasonable, adequate and in the best interests of the Settlement Class; (c) the application by Class Counsel for an award of attorneys' fees, costs, and expenses as provided for under the Settlement Agreement; (d) the application for Named Plaintiffs' service awards as provided for under the Settlement Agreement; (e) whether the release of Released Claims as set forth in the Settlement Agreement should be provided; (f) whether the Court should enter the [Proposed] Final Approval Order and Judgment; and (g) ruling upon such other matters as the Court may deem just and

appropriate, consistent with the Settlement Agreement. The Final Approval Hearing may, from time to time and without further notice to Settlement Class Members, be continued or adjourned by order of the Court.

The prior set hearing on July 30, 2026, at 2:00 p.m. is hereby canceled.
