JOINT STIPULATED DISMISSAL

Pursuant to Rule 41(a)(1)(A)(ii) of the Federal Rules of Civil Procedure, Plaintiff Dale Kessler (“Kessler”) and Defendant Samsung Electronics America, Inc. (“Samsung”) hereby stipulate and agree that: (1) all individual claims that Kessler asserted or could have asserted on his own behalf in the litigation are hereby dismissed *with* prejudice; and (2) the claims of the putative class asserted in the litigation are hereby dismissed *without* prejudice and *without* notice. Kessler and Samsung have resolved all issues concerning attorney’s fees and costs.

This dismissal does not affect the rights of any putative class member. The notice and approval requirements of Federal Rule of Civil Procedure 23(e) are inapplicable because this action has not been certified as a class, and a class is not proposed to be certified for purposes of settlement.
