Kokomo Solutions, Inc dba Kokomo24/7 ("Kokomo" or "we" or "us") is a technology vendor that works with the Los Angeles Unified School District. Kokomo values and respects the confidentiality of information we maintain on behalf of the Los Angeles Unified School District. Unfortunately, we are writing to advise you of a recent incident that may have involved some of your personal information. We are writing to advise you of the incident and to provide you with guidance on steps you can take in response to this incident, should you feel it is appropriate to do so.

What Happened? On December 11, 2024, we discovered unusual activity on our computer network. Upon identifying the issue, we promptly took steps to contain and remediate the incident. We also engaged a forensic security firm to investigate the incident and confirm the security of our computer systems. The forensic investigation determined that an unauthorized third party accessed certain files on our network on the day the incident was discovered.
