NetLine Corporation (“NetLine”) is writing to notify you of an event that may affect some of your information. This notice provides details about the event, the action we have taken, and resources available to you to help protect your information, should you feel it appropriate to do so.

**What Happened?** NetLine’s ongoing monitoring services recently detected some suspicious activity related to one public facing webserver. In response, NetLine took prompt steps to secure that server and conduct a comprehensive investigation. The investigation determined an unknown third party gained access to certain databases on the server without authorization on April 20, 2026. We undertook a thorough review of the relevant databases to confirm the information present, and to whom the information related, in order to notify potentially affected individuals.

**What Information Was Involved?** Our investigation determined that a limited amount of information provided as part of your business relationship with NetLine was contained in the relevant database, including your name, [REDACTED]. There is currently no evidence that any information has been misused for the purposes of identity theft or fraud.

**What We Are Doing.** In addition to securing the server and conducting the investigation and review detailed above, as an extra precaution, we are offering you access to 24 months of complimentary identity monitoring and identity theft protection services through Cyberscout, a TransUnion company. If you wish to activate these services, you may follow the instructions included in the enclosed *Steps You Can Take To Help Protect Personal Information*.

**What You Can Do.** We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors. You may also review the information contained in the enclosed *Steps You Can Take To Help Protect Personal Information*. There you will also find additional resources and information on the complimentary monitoring services we are making available to you. Please note, due to privacy restrictions, we are unable to automatically enroll you in the complimentary monitoring services. If you want to receive the complimentary monitoring services, you must follow the enrollment instructions in this letter.

## Steps You Can Take To Help Protect Personal Information

### Enroll in Monitoring Services

In response to the matter, we are providing you with access to Single Bureau Credit Monitoring/Single Bureau Credit Report/Single Bureau Credit Score services at no charge. These services provide you with alerts for 24 months from the date of enrollment when changes occur to your credit file. This notification is sent to you the same day that the change or update takes place with the bureau. Finally, we are providing you with proactive fraud assistance to help with any questions that you might have or in the event that you become a victim of fraud. These services will be provided by Cyberscout, a TransUnion company specializing in fraud assistance and remediation services.

To enroll in Credit Monitoring services at no charge, please log on to <https://bfs.cyberscout.com/activate> and follow the instructions provided. When prompted, please provide the following unique code to receive services:

In order for you to receive the monitoring services described above, you must enroll within ninety (90) days from the date of this letter. The enrollment requires an internet connection and e-mail account and may not be available to minors under the age of 18 years of age. Please note that when signing up for monitoring services, you may be asked to verify personal information for your own protection to confirm your identity.

### Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
