Dear Sample A. Sample,

New Jersey Compensation Rating & Inspection Bureau (“NJCRIB”) is writing to make you aware of a recent incident that may impact some of your personal information. While we are unaware of any attempted or actual identity theft associated with this incident, we are providing you with details about what happened, our response, and steps you may take to protect against potential misuse of your information, should you wish to do so.

**What Happened?** NJCRIB became aware of suspicious activity within our network. We promptly took steps to secure the system and initiated a thorough investigation in coordination with external cybersecurity specialists, to determine the full nature and scope of the incident. Our investigation determined that some of our computer systems were accessed by an outside threat actor between July 8, 2025, and August 5, 2025, and that certain administrative files may have been copied from the system without authorization during that time. We then conducted a detailed review of the files that may have been involved to determine what information was present and to whom it related. NJCRIB does not collect personal financial or health information tied to an individual claimant. **We confirmed your contact information on or around February 3, 2026.** You are receiving this notice because your information was identified in the potentially relevant files.

**What Information Was Involved?** The files contained your name, [Extra1].

**What We Are Doing.** In response to this incident, we took steps to secure our systems, including hiring external cybersecurity specialists, and commenced an investigation. We also promptly reported the event to federal law enforcement. We recognize the evolving nature of cyber security and have and will continue to enhance our existing technical safeguards. As an added precaution, we are offering you access to credit monitoring and identity restoration assistance services for [Extra2] months at no cost to you. The deadline to enroll in these services is May 29, 2026. A description of services and instructions regarding how to enroll can be found within the enclosed *Steps You Can Take to Help Protect Personal Information*. Please note that you must complete the enrollment process yourself as we are not permitted to enroll you in these services.

**What You Can Do.** In addition to enrolling in the credit monitoring services being offered to you, we encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors. Please also review the information contained in the enclosed *Steps You Can Take to Help Protect Personal Information*.

## Steps You Can Take To Help Protect Personal Information

### Enroll in Monitoring Services

To help protect your identity, we are offering complimentary access to Experian IdentityWorks<sup>SM</sup> for [Extra2] months.

## **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
