

NOTICE OF PROPOSED CLASS ACTION SETTLEMENT

Oliver v. Parksite, Inc.
Case No. 2025-CH-000056
Circuit Court of Kane County, Illinois

IF YOU WERE AFFECTED BY THE PARKSITE DATA BREACH THAT OCCURRED IN DECEMBER 2023 AND JANUARY 2024, A PROPOSED CLASS ACTION SETTLEMENT MAY AFFECT YOUR RIGHTS AND ENTITLE YOU TO A CASH PAYMENT.

A court has authorized this notice. This is not a solicitation from a lawyer.

You are not being sued.

Please read this Notice carefully and completely.

- A Settlement has been reached with Parksite, Inc. (“Parksite” or “Defendant”) in a class action lawsuit. This class action lawsuit concerned the targeted cyberattack on Parksite’s computer systems that occurred on or about December 2023 to January 2024 (the “Security Incident”). Certain files that contained private information were accessed. These files may have contained personal information such as names and Social Security Numbers.
- The lawsuit is called *Oliver v. Parksite, Inc.*, Case No. 2025-CH-000056, pending in the Circuit Court of Kane County, Illinois (the “Litigation”).
- Parksite denies that it did anything wrong, and the Court has not decided who is right.
- The parties have agreed to settle the lawsuit (the “Settlement”) to avoid the costs and risks, disruptions, and uncertainties of continuing the litigation.
- Parksite’s records indicate that you are a Class Member, and entitled to benefits under the Settlement. You may have received a previous notice directly from Parksite.
- Your rights are affected whether you act or don’t act. ***Please read this Notice carefully and completely.***

SUBMIT A CLAIM	The only way to receive benefits from this Settlement is by submitting a valid and timely Claim Form. The fastest way to submit your Claim Form is online at www.ParksiteSettlement.com. You may also call or email the Settlement Administrator to receive a paper copy of the Claim Form.	December 31, 2025
OPT OUT OF THE SETTLEMENT	You can choose to opt out of the Settlement and receive no payment. This option allows you to sue, continue to sue, or be part of another lawsuit against the Defendant related to the legal claims resolved by this Settlement. Basic Information

1. Why was this Notice issued?

The Circuit Court of Kane County, Illinois, authorized this Notice. You have a right to know about the proposed Settlement of this class action lawsuit, and about all of your options, before the Court decides whether to grant final approval of the Settlement. This Notice explains the lawsuit, your legal rights, what benefits are available, and who can receive them.

The lawsuit is called *Oliver v. Parksite, Inc.*, Case No. 2025-CH-000056, pending in the Circuit Court of Kane County, Illinois. The person that filed this lawsuit is called the “Plaintiff” (or “Settlement Class Representative”) and the company he sued, Parksite, Inc., is called the “Defendant.”

2. What is this lawsuit about?

This lawsuit alleges that from December 2023 to January 2024, a targeted cyberattack on Parksite's computer systems resulted in certain files that contained private information being accessed. These files may have contained personal information such as names and Social Security Numbers.

3. What is a class action?

In a class action, one or more individuals sue on behalf of other people with similar claims. These individuals are called the “Plaintiffs” or “Settlement Class Representatives.” Together, the people included in the class action are called a “Class” or “Class Members.” One court resolves the lawsuit for all Class Members, except for those who opt out from the settlement. In this Settlement, the Settlement Class Representative is Tyler Oliver, and everyone included in this Action are the Class Members.

4. Why is there a Settlement?

The Court did not decide whether the Plaintiff or the Defendant is right. Both sides have agreed to a Settlement to avoid the costs and risks of a trial, and to allow the Class Members to receive benefits from the Settlement. Plaintiff and his attorneys think the Settlement is fair and is best for all Class Members.

Who is in the Settlement?

5. Who is included in the Settlement?

The court has defined the Class this way: “All individuals residing in the United States whose Personal Information was compromised in the Data Breach discovered by Parksite in January 2024, including all those individuals who received notice of the breach.”

6. Are there exceptions to being included?

Yes. Excluded from the Class are: (1) the Judge in this case, and the Judge’s family and staff, (2) Parksite and its officers and directors; (3) anyone who validly excludes themselves from the Settlement; and (4) anyone who perpetrated the Security Incident.

The Settlement Benefits

7. What does the Settlement provide?

Parksite has agreed to pay for a number of different benefits. All Class Members can enroll in one year of **Credit Monitoring Services** by a credit agency. In addition to Credit Monitoring Services, Class Members may choose between **two cash payment options**:

OPTION 1: Select one or more of the following benefits:

- Out-of-Pocket Expenses
- Losses for Identity Theft or Fraud
- Compensation for Lost Time

OR

OPTION 2: Alternative Cash Payment.

- Receive a one-time \$35.00 cash payment

More information about each of these benefits is below. Full details are in Section III of the Settlement Agreement, available at www.ParksiteSettlement.com.

CREDIT MONITORING SERVICES

All Class Members can enroll in one year of Credit Monitoring Services by a credit agency. This benefit includes \$1 million of identity theft protection insurance.

CASH PAYMENT OPTION 1

Out-of-Pocket Expenses. If you incurred actual, documented out-of-pocket expenses due to the Security Incident, you can get back up to **\$600.00**. The losses must have occurred between December 25, 2023, and December 31, 2025.

This benefit covers out-of-pocket expenses like:

- fees for credit reports, credit monitoring, or freezing and unfreezing your credit
- cost to replace your IDs
- postage to contact banks by mail

You need to send proof, like receipts, to show how much you spent or lost. You can also send notes or papers you made yourself to explain or support other proof, but those notes or papers alone are not enough to make a valid claim.

Losses for Identity Theft or Fraud. If you lost money because of identity theft or fraud, you can get back up to **\$4,000.00**.

You will need to show that:

- the theft or fraud was probably caused by the Security Incident
- the losses are not already covered by **Out-of-Pocket Expenses** or **Compensation for Lost Time**
- you tried to prevent the loss or get your money back, such as by using insurance you already have

The losses must have occurred between December 25, 2023, and December 31, 2025.

You need to send proof, like bank statements, to show how much you spent or lost. You can also send notes or papers you made yourself to explain or support other proof, but those notes or papers alone are not enough to make a valid claim.

Compensation for Lost Time. Class Members who spent time responding to the Security Incident may claim up to three (3) hours, at \$25.00 per hour, for a maximum of **\$75.00**. This benefit counts toward the \$600.00 cap for **Out-of-Pocket Expenses**.

You must have spent the time on tasks related to the Security Incident. Some examples include things like changing your passwords, investigating suspicious activity in your accounts, and researching the Security Incident.

You must provide a brief description and attest that you spent the time claimed on tasks related to the Security Incident.

CASH PAYMENT OPTION 2

Alternative Cash Payment. Instead of the benefits in Cash Payment Option 1, you may claim a one-time **\$35.00** cash payment. You do not have to provide any proof or explanation to claim this payment.

8. What claims am I releasing if I stay in the Class?

If you stay in the class, you won't be able to be part of any other lawsuit against Parksite about the issues that this Settlement covers. The "Releases" section of the Settlement Agreement (Section X) describes the legal claims that you give up if you remain in the Class. The Settlement Agreement is available at www.ParksiteSettlement.com.

Submitting a Claim Form for a Settlement Payment

9. How do I submit a claim for a Settlement benefit?

The fastest way to submit your Claim Form is online at www.ParksiteSettlement.com. If you prefer, you can download a printable Claim Form from the website and mail it to the Settlement Administrator at:

10. Are there any important Settlement payment deadlines?

If you are submitting a Claim Form online, you must do so by December 31, 2025. If you are submitting a claim by U.S. mail, the completed and signed Claim Form, including supporting documentation, must be postmarked no later than December 31, 2025.

11. When will the Settlement benefits be issued?

The Court will hold a final approval hearing on January 29, 2026 at 9:00 a.m. (**see Question 18**). If the Court approves the Settlement, there may be appeals. We do not know if appeals will be filed, or how long it will take to resolve them if they are filed.

Settlement payments will be distributed if the Court grants final approval, and after any appeals are resolved.

The Lawyers Representing You

12. Do I have a lawyer in the case?

Yes, the Court appointed attorneys Raina C. Borrelli and Cassandra P. Miller of Strauss Borrelli PLLC, to represent you and other Class Members ("Settlement Class Counsel").

13. Should I get my own lawyer?

You will not be charged for Settlement Class Counsel's services. If you want your own lawyer, you may hire one at your expense.

14. How will Class Counsel be paid?

Settlement Class Counsel will ask the court to approve attorney's fees in the amount of \$120,000.00, which will be paid by Parksite.

Settlement Class Counsel will also ask for a \$3,000.00 Service Award payment for the Settlement Class Representative. Service Award Payment will also be paid by Parksite.

Excluding Yourself from the Settlement

15. How do I opt out of the Settlement?

If you do not want to be part of the Settlement, you must formally exclude yourself from the Settlement. This is called a Request for Exclusion, and is sometimes also called "opting out." If you opt out, you will not receive a Settlement payment, but you will keep any rights you may have to sue Parksite on your own about the legal issues in this case.

If you exclude yourself, you are telling the Court that you do not want to be part of the Settlement. You will not be eligible to receive any Settlement benefits if you exclude yourself.

The deadline to exclude yourself from the Settlement is December 1, 2025.

To be valid, your Request for Exclusion must have the following information:

- (1) the name of the Action: *Oliver v. Parksite, Inc.*, Case No. 2025-CH-000056, pending in the Circuit Court of Kane County, Illinois;
- (2) your full name, mailing address, telephone number, and email address;
- (3) personal signature; and
- (4) the words "Request for Exclusion" or a clear and similar statement that you do not want to participate in the Settlement.

You may only exclude yourself—not any other person.

Your Request for Exclusion must be submitted, postmarked, or emailed by December 1, 2025.

Commenting on or Objecting to the Settlement

16. How do I tell the Court if I like or do not like the Settlement?

If you are a Class Member and do not like part or all of the Settlement, you can object to it. Objecting means telling the Court your reasons for why you think the Court should not approve the Settlement. The Court will consider your views.

You cannot object if you have excluded yourself from the Settlement (**see Question 15**).

You must provide the following information for the Court to consider your objection:

- (1) the name of the Action: *Oliver v. Parksite, Inc.*, Case No. 2025-CH-000056, pending in the Circuit Court of Kane County, Illinois;
- (2) your full name and current mailing address;
- (3) a clear description of all the reasons you object; include any legal support you may have for your objection;
- (4) if you have hired your own lawyer to represent you at the Final Approval Hearing, provide their name and telephone number;
- (5) if you or your lawyer have objected in any other cases in the past five years, list the names, courts, and civil action numbers for each of those cases;
- (6) whether or not you or your lawyer would like to speak at the Final Approval Hearing;
- (7) your signature (or, if you have hired your own lawyer, your lawyer's signature).

For your objection to be valid, it must meet each of these requirements.

To be considered by the Court, you must file your complete objection with the Clerk of Court by December 1, 2025. You must also send copies of the objection to the Settlement Administrator.

17. What is the difference between objecting and excluding?

Objecting is telling the Court that you do not like something about the Settlement. You can object to the Settlement only if you do not exclude yourself from the Settlement. Excluding yourself from the Settlement is opting out and stating to the Court that you do not want to be part of the Settlement. If you opt out of the Settlement, you cannot object to it because the Settlement no longer affects you.

The Court's Final Approval Hearing

18. When is the Court's Final Approval Hearing?

The Court will hold a final approval hearing on **January 29, 2026 at 9:00 a.m. Central Time**, in Room 320 of the Circuit Court of Kane County, Illinois, at 100 S. Third Street, Geneva, Illinois.

At the final approval hearing, the Court will decide whether to approve the Settlement. The court will also decide how Settlement Class Counsel should be paid, and whether to award a Service Award payment to the Settlement Class Representative. The Court will also consider any objections to the Settlement.

If you are a Class Member, you or your lawyer may ask permission to speak at the hearing at your own cost (**See Question 16**).

The date and time of this hearing may change without further notice. Please check www.ParksiteSettlement.com for updates.

19. Do I have to come to the Final Approval Hearing?

No. Settlement Class Counsel will answer any questions the Court may have. You may attend at your own expense if you wish, but you do not have to. If you file an objection, you do not have to come to the Final Approval Hearing to talk about it; the Court will consider it as long as it was filed on time. You may also pay your own lawyer to attend, but you do not have to.

If I Do Nothing

20. What happens if I do nothing at all?

If you do nothing, you will not receive a benefit from this Settlement. You will also give up the rights described in **Question 8**.
