Palo Verde Hospital ("PVH") is committed to protecting the confidentiality and security of the information we maintain. We are writing to inform you about a recent data security incident that may have involved some of your information. This notice explains the incident, measures we have taken, and additional steps you can take in response.

What Happened: On March 6, 2025, we learned of an incident that disrupted the operations of some of our IT systems, and we immediately took steps to secure our systems and contain the incident. We also launched an investigation with the assistance of third-party forensic experts and notified law enforcement. Through our investigation, we determined that an unauthorized party accessed some of our systems between March 3, 2025, and March 6, 2025, and accessed or removed certain files. We then initiated a review and analysis of those files, which is ongoing, to determine what information they contained.

What Information Was Involved: Our review determined that your information was contained in the files, including some or all of the following: your name, contact information, demographic information, Social Security number, date of birth, medical record number, patient account number, diagnosis and treatment information, prescription information, provider name(s), date(s) of service, and/or health insurance information. For some patients, financial account and routing numbers may have also been involved.

What We Are Doing: We are notifying you of this incident to assure you that we take this matter very seriously. To help prevent something like this from happening again, we are taking steps to implement additional safeguards and technical security measures to further protect and monitor our systems. In addition, out of an abundance of caution, we secured the services of Experian to provide you with one year of complimentary identity monitoring services through Experian[®]'s IdentityWorksSM. This product helps detect possible misuse of your information and provides you with identity protection support focused on immediate identification and resolution of identity theft. IdentityWorks is free and enrolling in this program will not affect your credit score.

What You Can Do: We encourage you to enroll in the credit monitoring services we are offering you. We also recommend that you review the statements you receive from your providers and health insurer. If you see services that you did not receive, contact the issuer of the statement immediately. We also encourage you to remain vigilant about the possibility of fraud by reviewing your financial account statements for any suspicious activity. You should immediately report any suspicious activity to your financial institution.

ADDITIONAL STEPS YOU CAN TAKE

We remind you it is always advisable to be vigilant for incidents of fraud or identity theft by reviewing your account statements and free credit reports for any unauthorized activity. You may obtain a copy of your credit report, free of charge, once every 12 months from each of the three nationwide credit reporting companies. If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your state. You can obtain information from these sources about steps an individual can take to avoid identity theft as well as information about fraud alerts and security freezes. You should also contact your local law enforcement authorities and file a police report. Fraud Alerts: There are two types of general fraud alerts you can place on your credit report to put your creditors on notice that you may be a victim of fraud—an initial alert and an extended alert. You may ask that an initial fraud alert be placed on your credit report if you suspect you have been, or are about to be, a victim of identity theft. An initial fraud alert stays on your credit report for one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft with the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years. To place a fraud alert on your credit reports, contact one of the nationwide credit bureaus. A fraud alert is free. The credit bureau you contact must tell the other two, and all three will place an alert on their versions of your report. For those in the military who want to protect their credit while deployed, an Active-Duty Military Fraud Alert lasts for one year and can be renewed for the length of your deployment. The credit bureaus will also take you off their marketing lists for prescreened credit card offers for two years unless you ask them not to.

Credit or Security Freezes: You have the right to put a credit freeze, also known as a security freeze, on your credit file, free of charge, which makes it more difficult for identity thieves to open new accounts in your name. That's because most creditors need to see your credit report before they approve a new account. If they can't see your report, they may not extend the credit. *How do I place a freeze on my credit reports?* There is no fee to place or lift a security freeze. Unlike a fraud alert, you must separately place a security freeze on your credit file at each credit reporting company. You'll need to supply your name, address, date of birth, Social Security number and other personal information. After receiving your freeze request, each credit bureau will provide you with a unique PIN (personal identification number) or password. Keep the PIN or password in a safe place. You will need it if you choose to lift the freeze. *How do I lift a freeze*? A freeze remains in place until you ask the credit bureau to temporarily lift it or remove it altogether. If the request is made online or by phone, a credit bureau must lift a freeze within one hour. If the request is made by mail, then the bureau must lift the freeze no later than three business days after getting your request.

If you opt for a temporary lift because you are applying for credit or a job, and you can find out which credit bureau the business will contact for your file, you can save some time by lifting the freeze only at that particular credit bureau. Otherwise, you need to make the request with all three credit bureaus.
