5	<b>October 31, 2022</b> (extended from July 28, 2022)	Deadline for the Claims Administrator to report names and addresses of all persons and entities that submitted proper and timely requests for exclusion from the Settlement Class

9	<b>November 1, 2022</b> (extended from August 1, 2022)	Deadline for Class Counsel to File Reply Papers, if any, Regarding Motion for Attorney's Fees, Expenses, and Class Representative Service Awards

13	<b>November 7, 2022</b> (extended from August 5, 2022)	Settlement Class Counsel and Defendant may file any supplemental memoranda or submissions addressing any objections and/or opt-outs and any other matters in further support of final approval of the Settlement
