SETTLEMENT AGREEMENT & RELEASE

This Settlement Agreement and Release (the "Settlement Agreement") is entered into by and between Plaintiff Paula Sparkman, for herself and the Settlement Class Members (as defined below), and Defendants Comerica Bank and Conduent State & Local Solutions, Inc. (collectively, "Defendants"). Plaintiff and Defendants are referred to collectively in this Settlement Agreement as the "Parties."

I. <u>RECITALS</u>

This Settlement Agreement is made with reference to and in contemplation of the following facts and circumstances:

- 1. On April 26, 2023, Plaintiff initiated a lawsuit, captioned *Paula Sparkman v. Comerica Bank, et al.*, Case No. 4:23-cv-02028-DMR, against Defendants in the United States District Court for the Northern District of California (the "Action").
- 2. Plaintiff alleges in the Second Amended Complaint, on behalf of a proposed class and sub-class, the following claims against Defendants: a breach of contract claim, breach of the implied covenant of good faith and fair dealing claim, a claim of unlawful business practices under the California Unfair Competition Law, Cal. Bus. & Prof. Code § 17200, et seq. ("UCL"), and various violations of the Electronic Funds Transfer Act, 15 U.S.C. § 1693, et seq. ("EFTA"), including sections 1693g(a), 1693(b), 1693(f)(e), and 1693/.
- 3. Defendants deny all claims asserted in the Action. Defendants also deny all allegations of wrongdoing and liability in this Action.
- 4. The Parties and their counsel have conducted investigations of the facts and law underlying the claims asserted in this Action. In addition, the Parties and their counsel have conducted formal and informal discovery, including written discovery and depositions. The Parties and their counsel have also conducted a thorough assessment of the strengths and weaknesses of their respective cases.
- 5. The Parties and their counsel have engaged in extensive and arm's-length negotiations concerning settlement of the claims asserted in the Action, including participating in private mediation with the Honorable Jose Linares (Ret.), an experienced mediator of consumer class action lawsuits, and direct exchange of offers and proposed terms.
- 6. As a result of these efforts, the Parties enter into this Settlement Agreement. Subject to this Court's approval as required by Rule 23 of the Federal Rules of Civil Procedure, this Settlement Agreement will fully and forever resolve, discharge, and release all rights and claims of Plaintiff and the Settlement Class Members (as defined below) asserted in this Action.
- 7. Plaintiff and her counsel have concluded, based upon their investigation and thorough assessment, and taking into account Defendants' defenses, the expense and time necessary to continue to litigate the Action through trial, the risks and costs associated with any further proceedings and potential appeals, the uncertainties of proving the claims asserted in the Action, and the substantial benefits to be received under this Settlement Agreement, that

the terms of this Settlement Agreement are fair and reasonable, as well as in the best interest of Plaintiff and the Settlement Class Members.

8. Plaintiff, on behalf of herself and the Settlement Class Members, and her counsel agree to the terms of this Settlement Agreement and to have judgment entered without trial or adjudication of any factual or legal issue. Plaintiff and her counsel also agree that this Settlement Agreement, including any of its exhibits, does not constitute any evidence against, or any admission by Defendants.

THEREFORE, the Parties hereby stipulate and agree that, in consideration of the agreements, promises, and covenants set forth in this Settlement Agreement, and subject to approval of the Court, the Action shall be completely, fully, and finally settled and dismissed with prejudice as follows:

II. <u>DEFINITIONS</u>

In addition to the terms defined in other Sections of this Settlement Agreement, the following defined terms apply to this Settlement Agreement and its exhibits:

- 1. "Action" means *Paula Sparkman v. Comerica Bank, et al.,* Case No. 4:23-cv-02028-DMR.
- 2. "Class Counsel" or "Plaintiff's Counsel" means the law firms of Terrell Marshall Law Group, PLLC; Schlanger Law Group LLP; and Berger Montague PC.
- 3. "Court" means the United States District Court for the Northern District of California.
 - 4. "Effective Date" means the fifth day after the later of the following events:
 - a. The final disposition of any appeals from or review of the Final Approval Order; or
 - b. In the case of no appeal or review being filed, expiration of the applicable appellate period.
- 5. "EFTA Dispute" means disputes where Conduent's records reflect the cardholder reported one or more transactions as unauthorized or fraudulent under Regulation E and Defendants denied the dispute on the grounds that Defendants found a conflict in the information provided during an investigation.
- 6. "Final Approval Hearing" means the hearing held by the Court to determine whether to finally approve the Settlement, and whether to approve Plaintiff's Counsel's requested fees and expenses and the amount of the Service Award to Plaintiff.
- 7. "Final Approval Order" means the order and judgment that the Court enters after finally approving the Settlement.
- 8. "Notice" means the notice that will be provided pursuant to Section VI.3 of this Settlement Agreement, substantially in the same form as <u>Exhibit A</u>

- 9. "Notice Plan" means the proposed plan of sending notice to the Settlement Class of the proposed Settlement as set forth in Section VI.3 of this Settlement Agreement.
 - 10. "Objection Deadline" means 60 calendar days from the Settlement Notice Date.
 - 11. "Opt-Out Deadline" means 60 calendar days from the Settlement Notice Date.
- 12. "Preliminary Approval Order" means the order that the Court enters upon preliminarily approving the Settlement.
- 13. "Released Claims" means all claims to be released as set forth in Section X.2 of this Settlement Agreement.
- 14. "Released Parties" means Defendants Comerica Bank and Conduent State & Local Solutions, Inc., and their direct and indirect parents, subsidiaries, affiliated companies, and their agents, employees, directors, officers and attorneys.
- 15. "Releasing Parties" means the named Plaintiff and members of the Settlement Class to whom the Notice is sent and who do not exercise their right to opt out.
- 16. "Settlement" means the settlement contemplated by this Settlement Agreement.
- 17. "Settlement Administrator" means the third-party, American Legal Claim Services, LLC selected by Plaintiff after a competitive bid process, and not objected to by Defendants, to prepare and send notice to the Settlement Class and to administer payment of Settlement Awards.
- 18. "Settlement Award" means a payment that may be available to Settlement Class Members who do not exclude themselves from the Settlement.
- 19. "Settlement Class" means all persons issued a California Way2Go Card Prepaid Mastercard (1) who notified Conduent that one or more charges on their Way2Go account were unauthorized (2) for whom Conduent's records do not reflect indicia of first party fraud or a dispute over the quality of a good or service; and (3) who were denied reimbursement with a denial letter identified in Defendants' systems by the letter code FRD7-GO-Deny-Conflicting Info or FRD7 -DenyConflicting Info dated on or before December 10, 2024. For avoidance of doubt, the Settlement Class is comprised of the individuals whose accounts are identified on Exhibit C to this agreement.
- 20. "Settlement Class Member" means each person in the Settlement Class who does not request to be excluded from this Settlement.
- 21. "Settlement Fund" means the sum of \$1,956,000 to be paid by Defendants pursuant to Section IV of this Settlement Agreement. The Settlement Fund will be maintained in a qualified settlement account at a bank selected by the Settlement Administrator. The Settlement Administrator will act in accordance with the terms of this Settlement Agreement and the orders of the Court
- 22. "Settlement Notice Date" means the date the Settlement Notices are sent pursuant to the Notice Plan.

- 23. "Settlement Website" means the website www.
 CAUnauthorizedTransactionsSettlement.com, that will be established and maintained by the Settlement Administrator and contain the detailed notice in substantially the same form as Exhibit B and subject to approval by the Court.
- 24. "Service Award" means a payment, subject to the Court's approval, to the named Plaintiff in compensation for her involvement in this litigation and service on behalf of the class.

III. TERMS OF SETTLEMENT

1. <u>Conditional Certification of the Settlement Class</u>. For the sole purpose of settlement, the Parties and their counsel agree to conditional certification of the Settlement Class. Preliminary approval of the Settlement Class shall not be deemed a concession that certification of a litigation class is proper, and it will not preclude Defendants from challenging class certification in the event the Court does not approve the Settlement. No agreements made or entered into by Defendants in connection with this Settlement may be used by Plaintiff, any person in the Settlement Class, or any other person to establish any liability or any element of class certification in this Action or any other proceedings.

IV. <u>SETTLEMENT CONSIDERATION</u>

- 1. <u>Settlement Fund.</u> Defendants shall pay \$1,956,000 into a non-reversionary Settlement Fund. Plaintiff may seek a Service Award and Class Counsel may seek reasonable fees and costs from the Settlement Fund as described below.
 - a. Payment to Plaintiff. Plaintiff may move the Court for a Service Award for her time and effort in connection with this Action to be paid from the Settlement Fund. The Settlement Administrator shall issue the approved Service Award from the Settlement Fund per the directions of the Court and Class Counsel within five (5) days after the Effective Date. If the Court awards a Service Award to Plaintiff that is less than requested, this Settlement Agreement will remain in full force and will continue to be binding on all Parties, including the Settlement Class Members.
 - b. <u>Litigation Expenses and Attorneys' Fees.</u> Class Counsel will move the Court for an award of reasonable attorneys' fees and expenses to be paid from the Settlement Fund. Class Counsel will file their motion for an award of attorneys' fees, costs, and the Service Award to Plaintiff on or before the Settlement Notice Date. The Settlement Administrator will post Class Counsel's motion for an award of fees, costs, and Service Award on the Settlement Website within one business day after it is filed with the Court. The Settlement Administrator shall pay the attorneys' fees and expenses awarded by the Court to Class Counsel within two (2) days after the Effective Date. Defendants are free to oppose the amount of the award requested by Class Counsel.

- 2. <u>Distributions to Settlement Class Members</u>. There will be no claims process. Each Settlement Class Member shall be paid a single Settlement Award:
 - a. Settlement Class Members will receive a Settlement Award that is the Settlement Class Member's percentage share of the Settlement Fund. The percentage shall be calculated by dividing the amount of the Settlement Class Member's EFTA Dispute amount by the value of all Settlement Class Members' EFTA Dispute amounts.
 - b. Settlement Awards may be made either by check or by an alternative payment platform selected and administered by the Settlement Administrator, within 30 days after the Effective Date. Settlement Class Members will not be required to submit claims in order to receive a Settlement Award. Checks will be valid for 120 days from issuance.
- 3. <u>Payment Information.</u> Within three (3) days from the date of the filing of the Motion for Preliminary Approval, the Settlement Administrator shall provide Defendants with a completed and signed W-9 and wiring instructions on the letterhead of the bank the Settlement Administrator selects to deposit the Settlement Funds in.
- 4. <u>Funding the Settlement</u>. Within ten (10) days from the date of the Preliminary Approval Order, Defendants will make a payment of \$24,936 to cover the estimated costs of Settlement Administration. Any remaining funds not used by the Settlement Administrator to cover its costs shall be added to the Settlement Fund. Within ten (10) days from the date of the Final Approval Order, Defendants shall pay the balance of the Settlement Fund (\$ 1,931,064) to the Settlement Administrator, to be held in a qualified settlement fund account at a bank selected by the Settlement Administrator. The payments set forth in this paragraph represent the only payments Defendants shall pay pursuant to this Agreement. If this Settlement is terminated, for any cause, the portions of the Settlement Fund not already used to pay administration costs incurred before the termination date will be returned to Defendants by the Settlement Administrator.
- 5. <u>Processing the Settlement.</u> In the event there are any issues or claims relating to the administration of the settlement, including, but not limited to, the payment of claims, the notice to Settlement Class Members, and the safeguarding of the Settlement Class Members' personally identifiable information ("PII") and financial account information, neither Class Counsel, Plaintiff, Defendants, nor Defendants' Counsel shall bear any responsibilities for such claims, which responsibility shall reside with the Settlement Administration.
- 6. <u>Prospective Relief.</u> As additional consideration, Defendants shall stipulate to an injunction providing the following: Conduent will revise its form letters so that they no longer list conflicting information as a reason for denying California Way2Go cardholder unauthorized transaction disputes and shall retrain its fraud investigators consistent with the revised letters.
- 7. <u>Unclaimed Settlement Funds</u>. Settlement Award payments that are not claimed within 120 days after the date of issuance shall be voided.

- 8. Redistribution of Unclaimed Settlement Funds. Any unclaimed settlement funds shall be redistributed to Settlement Class Members who claimed their first payment ("Qualified Settlement Class Members") if the amount due to the Qualified Settlement Class Member would be at least \$20.00 under the terms of this paragraph. Qualified Settlement Class Members payment is calculated according to their percentage share of the unclaimed settlement funds. Each Qualified Settlement Class Member's percentage share of the unclaimed settlement funds shall be calculated by dividing the amount of the Qualified Settlement Class Member's EFTA Dispute amount by the value of all Qualified Settlement Class Members' EFTA Dispute amounts multiplied by the funds available for the second distribution. If the resulting payment to the Qualified Settlement Class Member is at least \$20.00, the Qualified Settlement Class Member will receive a second payment via the same method as their first payment. Payments that are not claimed within 120 days after the date of issuance shall be voided. If the resulting amount is less than \$20.00, then a second payment will not be sent to the Qualified Settlement Class Member and the funds will be allocated proportionally to Qualified Settlement Class Members receiving second distribution checks.
- 9. <u>Cy pres Award</u>. Any amounts remaining in the Settlement Fund, after the first round of payments and any redistribution, if applicable, shall be distributed in *cy pres* to the Consumer Federation of California.

V. <u>TAXES</u>

- 1. Qualified Settlement Fund. Plaintiff and Defendants agree that the account into which the Settlement Fund is deposited is intended to be and will at all times constitute a "qualified settlement fund" within the meaning of Treas. Reg. § 1.468B-1. The Settlement Administrator will timely make elections as necessary or advisable to carry out required duties including, if necessary, the "relation back election" (as defined in Treas. Reg. § 1.468B-1(j)(2)) back to the earliest permitted date. These elections will be made in compliance with the procedures and requirements contained in applicable Treasury Regulations promulgated under Section 1.468B of the Internal Revenue Code of 1986, as amended (the "Code"). It is the responsibility of the Settlement Administrator to cause the timely and proper preparation and delivery of the necessary documentation for signature by all necessary parties, and thereafter to cause the appropriate filing to occur.
- 2. <u>Section 1.468B of the Internal Revenue Code</u>. For the purpose of Section 1.468B of the Internal Revenue Code and the Treasury Regulations thereunder, the Settlement Administrator will be designated as the "administrator" of the non-reversionary Settlement Fund. The Settlement Administrator will cause to be timely and properly filed all informational and other tax returns necessary or advisable with respect to the non-reversionary Settlement Fund (including, without limitation, the returns described in Treas. Reg. § 1.468B-2(k)). These returns will reflect that all taxes (including any estimated taxes, interest or penalties) on the income earned by the non-reversionary Settlement Fund are to be paid out of the non-reversionary Settlement Fund.

3. <u>Tax Treatment.</u> All taxes arising in connection with income earned by the non-reversionary Settlement Fund, including any taxes or tax detriments that may be imposed upon Defendants with respect to any income earned by the non-reversionary Settlement Fund for any period during which the non-reversionary Settlement Fund does not qualify as a "qualified settlement fund" for federal or state income tax purposes will be paid by the Claims Administrator from the non-reversionary Settlement Fund.

Any person or entity that receives a distribution from the non-reversionary Settlement Fund will be solely responsible for any taxes or tax-related expenses owed or incurred by that person or entity by reason of that distribution. These taxes and tax-related expenses will not be paid from the non-reversionary Settlement Fund.

VI. PRELIMINARY APPROVAL

4. Motion for Preliminary Approval. On or before May 5, 2025, Plaintiff will move the Court for entry of the Preliminary Approval Order, which shall specifically include provisions that: (a) preliminarily approve the Settlement reflected herein as fair, adequate and reasonable to the Settlement Class, and within the reasonable range of possible final approval; (b) conditionally certify the Settlement Class for settlement purposes only and appoint Class Counsel as counsel for the Settlement Class for settlement purposes only; (c) approve the forms of Class Notice and find that the Notice Program constitutes the best notice practicable under the circumstances, provides due and sufficient notice to the Settlement Class and fully satisfies the requirements of due process and Federal Rule of Civil Procedure 23; (d) direct that notice be provided to the Settlement Class, in accordance with this Agreement, within thirty (30) days following entry of the Preliminary Approval Order (the "Notice Deadline"); (e) establish a procedure for Settlement Class Members to object to the Settlement or exclude themselves from the Settlement Class, and set a date sixty (60) days after the Notice Deadline, after which no one shall be allowed to object to the Settlement or exclude himself or herself from the Settlement Class or seek to intervene; (f) approve the Notice and distribution of the Settlement Proceeds described herein; (g) pending final determination of whether the Settlement should be approved, stay all proceedings in the Action except those related to effectuation of the Settlement; and (h) schedule a hearing on Final Approval of the Settlement, which shall be scheduled no earlier than thirty (30) days after the Opt-Out and Objection Deadline and the CAFA statutory notice period of at least ninety (90) days after the CAFA Notice is provided.

VII. <u>ADMINISTRATION AND NOTICE</u>

1. <u>Settlement Administrator</u>. The Settlement Administrator shall be responsible for administration of this Settlement. The Settlement Administrator shall be allowed to communicate freely with the Parties' counsel and will provide monthly reports to Parties' counsel relating to the Notice and Settlement Payment rates, and such other matters as the Parties' counsel may request.

- 2. <u>Payment of Administration and Notice</u>. All costs of administering this Settlement will be paid from the Settlement Fund.
 - 3. <u>CAFA Notice.</u> Within 10 days after Plaintiff files the motion for preliminary approval, Plaintiff and Defendants shall work with the Settlement Administrator to provide the notice to the government officials required under 28 U.S.C. § 1715. In no event shall the Final Approval Hearing take place prior to the expiration of the Objection and Opt-Out Deadlines and the CAFA statutory notice period of at least ninety (90) days.
- 4. <u>Notice and Fund Distribution Plan</u>. The Settlement Administrator shall provide notice as detailed below within thirty (30) calendar days after the issuance of the Preliminary Approval Order:
 - a. <u>Notice by U.S. Mail</u>. The Settlement Administrator will provide individual Postcard Notice through:
 - i. U.S. mail to the most recent address for each Settlement Class Member reflected in Defendants' records, and corrected through the National Change of Address system or similar commercial database. Defendants shall ensure that the contact information it provides is the most recent information provided to either Defendants or the California Department of Child Support Services by the Settlement Class Member.
 - b. <u>Notice by email.</u> The Settlement Administrator will provide individual notice by email to all Settlement Class Members for whom Defendants have an email address. Where Defendants have both an email and mailing address, notice will be sent to both.
 - c. Settlement Website. Within fourteen (14) calendar days from entry of the Preliminary Approval Order, the Settlement Administrator will establish and maintain the Settlement Website, which will display, at a minimum, the operative Complaint, Postcard Notice, content of the Website Notice, this Settlement Agreement, an opt-out form that can be printed and returned, and the Preliminary Approval Order. The Settlement Website will also allow Settlement Class Members to look up their estimated Settlement Award and elect to receive their payment by an alternative payment platform selected and administered by the Settlement Administrator. Within one business day after Class Counsel files a motion for an award of attorneys' fees, costs and Service Award to Plaintiff, that motion will also be displayed on the Settlement Website. The Settlement Website will be terminated 90 days after the negotiation period for checks sent to Settlement Class Members ends.

VIII. OPT-OUT PROCESS

- 1. Opt-Out Requirements. Individuals in the Settlement Class may exclude themselves from the Settlement Class by advising the Settlement Administrator in writing no later than the Opt-Out Deadline that they do not want to be a class member. All such writings must include the name and address of the individual opting out, and if mailed, must be postmarked no later than the Opt-Out Deadline. All persons in the Settlement Class will be bound by this Settlement and judgments of this Court in this Action unless they exclude themselves in writing by the Opt-Out Deadline.
- 2. <u>Retention of Opt-Outs</u>. The Settlement Administrator will retain a copy of all opt-out requests and will provide copies to the Parties' counsel upon request.

IX. OBJECTIONS

- 1. <u>Right to Object</u>. Any Settlement Class Member who desires to object to the fairness of this Settlement should file a written objection with the Court by the Objection Deadline. The written objection must provide the objector's name, address, and telephone number, and the reason(s) for the objection.
- 2. Right to Appear at Final Approval Hearing. Any Settlement Class Member who objects to Settlement may appear at the Final Approval Hearing, including through an attorney hired at the objector's expense. Such objectors or their attorneys intending to appear at the Final Approval Hearing should file a notice of appearance with the Court no later than ten (10) days before the Final Approval Hearing. The Court shall determine whether a Settlement Class Member's failure to comply with the provisions herein shall waive and forfeit rights to appear and/or object separately. Objectors shall be bound by the terms of this Settlement and the orders and judgments of this Court.

X. FINAL APPROVAL

- 1. <u>Declaration of Notice by Settlement Administrator</u>. The Settlement Administrator shall provide the Parties' counsel no later than twenty-one (21) days before the Final Approval Hearing with a declaration stating that the Notice required by this Settlement Agreement and the Preliminary Approval Order has been completed.
- 2. <u>Motion for Final Approval Order</u>. After completion of the Notice Plan and the expiration of the Opt-Out and Objection Deadlines and the CAFA statutory notice period of at least ninety (90) days, and no later than fourteen (14) days before the Final Approval Hearing, Plaintiff's counsel shall move the Court to enter the Final Approval Order. Plaintiff's counsel shall file a memorandum addressing any valid objections, and Defendants' counsel may, but is not required to, file an additional memorandum in response.
- 3. <u>Final Approval Order</u>. This Settlement Agreement is subject to and conditioned upon the issuance by the Court of a Final Approval Order that grants approval of this Settlement and:

- a. Finds that the notice under the Notice Plan satisfies the requirements of Due Process and Rule 23 of the Federal Rules of Civil Procedure;
- b. Finds that the Settlement Agreement is fair, reasonable, and adequate to the Settlement Class Members;
- c. Finds that Plaintiff and Class Counsel have adequately represented the Settlement Class Members;
- d. Finds that each Settlement Class Member shall be bound to this Settlement Agreement, including the release and covenant not to sue in Section XI;
- e. Requires Defendants' compliance with the injunctive relief described in IV.6 of this agreement;
- f. Approves this Settlement;
- g. Dismisses on the merits with prejudice all claims of Plaintiff and the Settlement Class Members asserted in this Action; and
- h. Retains jurisdiction of all matters relating to the administration, implementation, interpretation, and enforcement of this Settlement.
- 4. <u>Post-Distribution Accounting.</u> Within 21 days after all funds have been paid to Settlement Class Members, *cy pres* beneficiaries, and any others pursuant to the Settlement Agreement, the parties shall file a Post-Distribution Accounting Form containing the following information:
 - a. The total settlement fund, the total number of class members, the total number of class members to whom notice was sent and not returned as undeliverable, the number and percentage of claim forms submitted, the number and percentage of opt-outs, the number and percentage of objections, the average, median, maximum, and minimum recovery per claimant, the method(s) of notice and the method(s) of payment to class members, the percentage of success for each method of notice and payment (if known), the number and value of checks not cashed, the amounts distributed to each *cy pres* recipient, the administrative costs, the attorneys' fees and costs, the attorneys' fees in terms of percentage of the settlement fund, plaintiffs' counsel's updated lodestar total, and the lodestar multiplier.
 - b. Where injunctive and/or other non-monetary relief has been obtained, discuss the benefit conferred on the class.
 - c. The Settlement Administrator shall post the completed Form to the Settlement Website within one business day of filing.

XI. RELEASE OF CLAIMS

- 1. <u>Release</u>. As of the Effective Date, Plaintiff and each Releasing Party, hereby release, resolve, relinquish, and discharge forever each of the Released Parties from each of the Released Claims as defined below.
- 2. <u>Released Claims</u>. Released Claims means any and all claims, causes of action, suits, obligations, debts, demands, agreements, promises, liabilities, damages, losses, controversies, costs, expenses, and attorneys' fees of any nature whatsoever, that in arise out of the identical factual predicate in Plaintiff's Second Amended Complaint, including any Electronic Funds Transfer Act, breach of contract, breach of the implied covenant of good faith and fair dealing or Unfair Competition Law claims arising from Defendants' denial of Plaintiff's and the Settlement Class Members' unauthorized transfer disputes submitted to Defendants.
- 3. <u>Waiver of California Civil Code Section 1542</u>. By not excluding themselves from the Action and to the fullest extent they may lawfully waive such rights, Plaintiff and the Settlement Class Members are deemed to acknowledge and waive Section 1542 of the Civil Code of the State of California and any law of any state or territory that is equivalent to Section 1542. Section 1542 provides that:

A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE AND THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASE PARTY.

With respect to the subject matter of the Released Claims, Plaintiff and Settlement Class Members expressly waive and relinquish any and all rights and benefits that they may have under, or that may be conferred upon them by, the provisions of Section 1542 of the Civil Code of the State of California, or any other law of any state or territory that is similar, comparable or equivalent to Section 1542, to the fullest extent they may lawfully waive such rights.

4. <u>Covenant Not to Sue</u>. Plaintiff, each Settlement Class Member, and each Releasing Party will be deemed to have agreed not to sue any Released Party with respect to any of the Released Claims and to have agreed to be forever barred from doing so.

XII. <u>TERMINATION OF AGREEMENT</u>

- 1. <u>The Parties' Right to Terminate Settlement</u>. The Parties shall have the right to unilaterally terminate this Settlement Agreement by providing written notice of its election to do so to the other party within fourteen (14) calendar days of any of the following events:
 - a. The Court rejects, materially changes or modifies, or declines preliminary or final approval of the Settlement Agreement. A material change or modification shall include a change to the Settlement Proceeds, the Released Claims, or injunctive relief;
 - b. An Appellate Court reverses the Final Approval Order;
 - c. The Effective Date does not occur;

- d. A party, its counsel or the Settlement Administrator breaches the terms of this Settlement Agreement prior to the Effective Date.
- e. Within ten days of the Court-ordered deadline for exclusions, Defendants will have the absolute discretionary right (but not obligation) to terminate the Settlement and this Agreement if the number of valid optouts meets or exceeds 5% or more of the Settlement Class Members.

XIII. NO ADMISSION OF LIABILITY

- 1. <u>Denial of Liability</u>. Defendants deny any liability or wrongdoing of any kind in connection with the claims alleged in this Action. Defendants have denied and continue to deny each and every material factual allegation in this Action. Nothing in this Settlement Agreement and all acts performed in furtherance of this Settlement Agreement shall constitute an admission by Defendants of wrongdoing or liability in this Action. Nothing in this Settlement Agreement and all acts performed in furtherance of this Settlement Agreement shall constitute an admission by Defendant of the truth of any factual allegations in this Action. Nothing in this Settlement Agreement shall constitute an admission by Defendants that all Settlement Class Members have standing to assert a claim under the UCL. Nothing in this Settlement Agreement shall constitute an admission by Defendants that all California Way2Go cardholders have standing to assert a claim under the UCL. While Defendants deny any liability, they have concluded that further litigating this Action would be expensive and waste time and resources. Thus, Defendants have concluded that it is desirable to fully and finally settle this Action.
- 2. <u>Federal Rule of Evidence 408</u>. Pursuant to Rule 408 of the Federal Rules of Evidence, this Settlement Agreement and any related documents filed or created in connection with this Settlement Agreement shall be inadmissible as evidence in any proceeding, except as necessary to approve, interpret, or enforce this Settlement Agreement.

XIV. GENERAL PROVISIONS

- 1. <u>Entire Agreement</u>. This Settlement Agreement and its exhibits constitute the entire agreement between the Parties.
- 2. <u>Jurisdiction</u>. This Court shall retain continuing and exclusive jurisdiction over the Parties to this Settlement Agreement, including the Settlement Class Members, and the administration and enforcement of this Settlement Agreement.
- 3. <u>No Construction Against Drafter</u>. This Settlement Agreement will be deemed to have been drafted by the Parties, and any rule that a document shall be interpreted against the drafter will not apply.
- 4. <u>Authority</u>. Each person executing this Settlement Agreement on behalf of any of the Parties hereto represents that such person has the authority to so execute this Settlement Agreement.

- 5. <u>No Oral Modifications</u>. This Settlement Agreement may not be amended or modified in any manner except by a writing signed by Defendants and Class Counsel, and approved by the Court.
- 6. <u>No Assignment</u>. No party to this Settlement Agreement has heretofore assigned, transferred, or granted, or attempted to do so, any of the claims or causes of action disposed of by this Settlement Agreement.
- 7. <u>Agreement Binding on Successors in Interest</u>. This Settlement Agreement is binding on and shall inure to the benefit of the respective heirs, successors, and assigns of the Parties.
- 8. <u>Resolution of Disputes</u>. Any disputes regarding the administration of this Settlement Agreement that the Parties cannot resolve between themselves will be decided by the Court.
- 9. <u>Execution in Counterparts</u>. This Settlement Agreement may be executed in any number of counterparts, each of which shall be deemed an original, but all of which shall constitute one and the same instrument.
- 10. <u>Signatures</u>. This Settlement Agreement may be executed via DocuSign or any other electronic signature platform that complies with the E-Sign Act.
- 11. <u>Notices</u>. All notices to counsel provided herein shall be sent by electronic mail with a hard copy sent by overnight mail to:

Why did I get a postcard notice?

The postcard notice and this website tell you about the settlement of a class action lawsuit, *Paula Sparkman v. Comerica Bank, et al.* brought on behalf of all persons issued a California Way2Go Prepaid Mastercard who had their unauthorized transfer dispute denied for conflicting information. **You received a postcard notice because our records indicate you are a member of the group of people affected, called the "class."** This notice gives you a summary of the terms of the proposed settlement agreement, explains what rights class members have, and helps class members make informed decisions about what action to take.

The Court approved this notice because you have a right to know about a proposed settlement of a class action lawsuit, and about all of your options, before the Court decides whether to approve the settlement. Learning About the Lawsuit

What is this lawsuit about?

The lawsuit claims that Comerica Bank and Conduent State & Local Solutions, Inc. violated the Electronic Funds Transfer Act, violated the California Unfair Competition Law, and breached their contract by denying California Way2Go cardholder's disputes involving alleged unauthorized transactions for conflicting information.

Comerica Bank and Conduent State & Local Solutions, Inc. deny that they did anything wrong.

Why is there a settlement in this lawsuit?

The parties agreed to settle, which means they have reached an agreement to resolve the lawsuit. Both sides want to avoid the risk and expense of further litigation.

In a class action, someone called a Class Representative (in this case Paula Sparkman) sues on behalf of all people who have similar claims. Defendants have agreed not to oppose this case proceeding as a class for settlement purposes.

The Court has not decided this case in favor of either side.

What happens next in this lawsuit?

You have until [date] to object to or opt out of the settlement, with further details on these options provided below.

The Court will hold a final approval hearing to decide whether to approve the settlement. The hearing will be held by videoconference:

Learning About the Settlement

What does the settlement provide?

Comerica Bank and Conduent State & Local Solutions, Inc. have agreed to create a \$1,956,000.00 Settlement Fund to be divided among all the Settlement Class Members. This money will also be used to pay for costs and fees approved by the Court, including the cost of administering this settlement (expected to be approximately \$[dollar <mark>amount</mark>]).

The portion of the fund that each Settlement Class Member will receive will be determined based on the value of each Settlement Class Member's disputed claim. If funds remain after the first round of payments to class members, a second round of payments will be issued to those class members that accepted the first payment.



Receiving a Payment

Do I have a lawyer in this lawsuit?

In a class action, the court appoints class representatives and lawyers to work on the case and represent the interests of all the class members. For this settlement, the Court has appointed the following individuals and lawyers.

Your lawyers:

- Beth E. Terrell, Blythe Chandler, and Jasmin Rezaie-Tirabadi from Terrell Marshall Law Group PLLC
- Sophia M. Rios from Berger Montague PC
- Daniel A. Schlanger from Schlanger Law Group LLP

These are the lawyers who negotiated this settlement on your behalf. They are experienced in handling similar cases.

If you want to be represented by your own lawyer, you may hire one at your own expense.

Do I have to pay the lawyers in this lawsuit?

Lawyers' fees and costs will be paid from the Settlement Fund. **You** will not have to pay the lawyers directly.

To date, the lawyers have not been paid any money for their work or the expenses that they have paid for the case. To pay for some of their time and risk in bringing this case without any guarantee of payment unless they were successful, your lawyers will request, as part of the final approval of this Settlement, that the Court approve a payment of up to \$489,000 (which is 25% of the settlement fund) in attorneys' fees plus the reimbursement of \$56,536 in out-of-pocket expenses.

Lawyers' fees and expenses will only be awarded if approved by the Court as a fair and reasonable amount. You have the right to object to the lawyers' fees even if you think the settlement terms are fair. The lawyers' complete request will be filed with the Court and posted to this website no later than [DATE].

Your lawyers will also ask the Court to approve a payment of \$[dollar

amount] to the Class Representative for the time and effort she contributed to the case. If approved by the Court, this will be paid from the Settlement Fund.

Opting Out

What if I don't want to be part of this settlement?

You can exclude yourself, which is often referred to as "opting out" of the settlement. If you do, you will not receive payment and cannot object to the settlement. However, you will not be bound or affected by anything that happens in this lawsuit. That means that you keep the right to sue Comerica Bank or Conduent State & Local Solutions, Inc. or be part of another case against them about the issues in this lawsuit. Objecting

What if I disagree with the settlement?

If you disagree with any part of the settlement (including the lawyers' fees) but don't want to opt out, you may object.

You should give reasons why you think the Court should not approve it and say whether your objection applies to just you, a part of the class, or the entire class. The Court will consider your views. The Court can only approve or deny the settlement — it cannot change the terms of the settlement. If the Court denies approval, no settlement payments will be sent out, and the lawsuit will continue. If that is what you want to happen, you should object. You may, but don't need to, hire your own lawyer to help you.

To object, you must send a letter to the Court that:

- (1) includes the case name and number (*Paula Sparkman v. Comerica Bank, et al.,* Case No. 23-cv-02028-DMR)
- (2) includes your full name, address and telephone number;
- (3) (if you are represented) include the name, address, and telephone number of counsel;
- (4) states the reasons for your objection;
- (5) says whether either you or your lawyer intend to appear at the final approval hearing;
- (6) includes your signature.
