4 Granting Preliminary Approval of Class Action Settlement and Certification of a Settlement Class,
5 signed and entered on June 5, 2026, shall be amended *nunc pro tunc*, as follows:

6 1. Last day for Total Vision to provide Class List to the Settlement Administrator is
7 June 12, 2026;

8 2. Last day for Total Vision to pay Settlement Fund to the Settlement Administrator
9 for the benefit of the Class is July 6, 2026;

10 3. Last day for Settlement Administrator to mail the Summary Class Notice to Class
11 Members is July 6, 2026;

12 4. Last day for Class Members to file objections to settlement or to request exclusion
13 from the Class is 60 days after the Class Notice Date or September 4, 2026; and

14 5. Last day for Class Members to submit claim forms is 90 days after the Class Notice
15 Date or October 5, 2026.
