Pursuant to the Court's Pre-Trial Scheduling Order (ECF No. 46) and the Court's email on July 12, 2021, the parties write jointly to update the Court on the settlement negotiations in this case. During their supplemental Rule 26(f) conference on July 7, 2021, the parties discussed the continued possibility of settlement. The parties are now actively engaging in renewed settlement negotiations and have made progress toward reaching a settlement agreement.
